

NEW FROM LFEE EUROPE!

Our 3-week Immersion Course Programme for Secondary Teachers of French & Spanish is now available as an ONLINE COURSE

This online course meets **GTC Scotland's policy requirements for language residency** and is offered as an alternative to our 3-week immersion course scheduled for Summer 2021.

In light of the continuing COVID crisis, we have decided - in consultation with GTCS - to offer our 3-week course as an online alternative. Participants to this course will meet the requirements for residency and you will be able to attend an optional 1 week course in Malaga or Montpellier at the end of July should the Covid situation allow us to do so.

WHEN?

The dates of the online course are **Monday 26th April to Friday 18 June 2021**. However, our very flexible approach will allow teachers extra time over the summer to complete their course should they wish to do so. This will be dealt on a case-by-case basis.

Registration closes on 19 February 2021.

WHAT FORMAT?

36 hours of home learning and live teaching and interaction with colleagues from the end of April until the end of June.

6 live sessions held on Zoom with a native speaker of French or Spanish over 6 weeks. The rest of the course can be organised by the teachers themselves at a time that suits their needs.

LFEE EUROPE

The content of our 3-week residency course will be condensed into this online course to offer a

blend of Methodology, Language Learning and Culture.

A shared online space will be available for participants to interact and post questions and

comments.

Participants will receive a Certificate at the end of the course and will be able to apply to GTCS

to satisfy their residency requirement.

COST?

The cost of this online course is £750 for the full course*.

First Payment of 50% to be made to LFEE Europe Ltd by 26 February 2021 with the balance due

4 weeks prior to the start of the course.

*Note: For teachers who have already secured Erasmus+ funding for a 3-week course, you are

entitled to use the €350 amount for "Organisational Support" included in your grant award

towards the cost of the online course fee. We advise that you contact the British Council

Erasmus+ Team to ask if you would be entitled to use any of the "Course Tuition Fee" element of

your grant award to put towards this online course. The balance of the online course fee cost

may have to be paid personally by teachers depending on advice from the British Council.

ENHANCING PROFESSIONAL DEVELOPMENT

As an optional follow-up to the online training programme, we are offering the opportunity to

enhance your professional and personal development through our 1-week training programme

in language and pedagogy being offered in Malaga and Montpellier from Saturday 24 July to

Saturday 31 July 2021.

LFEE EUROPE

Please note that participation in the online course is sufficient for Scottish Secondary practitioners to meet GTC Scotland's policy requirements for language residency. The 1-week course in Malaga or Montpellier is optional.

The aims of this 1-week course are to:

- Explore strategies for extending learners' language skills through Interdisciplinary activities
- Develop new skills for language teaching and transferability across subject area
- Explore the CLIL approach and see how to Plan a CLIL lesson
- Join in practical CLIL workshops
- Develop and consolidate participants' knowledge of French / Spanish
- Increase participants' cultural awareness of France / Spain

Teachers who have secured Erasmus+ funding for the 3-week course can use some of this funding to pay for the cost of the course fee and travel to/from Malaga or Montpellier to attend the course.

For any teachers interested in attending the 1-week course in Malaga or Montpellier who do not have Erasmus+ funding, you can self-fund the cost of the course if you wish. Please contact Roslynn Main at LFEE Europe for further information (contact details below).

Due to the ongoing Covid situation, LFEE Europe will confirm in April 2021 if the 1-week courses in Malaga and Montpellier from 24-31 July 2021 will go ahead. **No travel arrangements should be made until confirmation is received from LFEE Europe.**
